Subject: Transportation Waiver and Release Form

1. I understand that my execution of this Transportation Waiver and Release is a prerequisite for transportation by any person designated by CCA-CFA other than the undersigned parents/guardians in conjunction with any CCA-CFA related event. Such events may include, but are not limited to, taking a student to his or her home if circumstances require. I further understand that there are risks and dangers inherent in driving.
  
2. I understand that in order to be transported by anyone other than a player’s own parent/guardian, there is agreement to assume all risks and to release and hold harmless the volunteer driver(s), CCA-CFA, and its Board of Directors, officers, agents, and employees and all governmental and public entities associated therein (collectively the “Released Parties”). In the event of any injury to person or property during such transportation, all applicable insurance coverage maintained by the undersigned shall be considered primary coverage and shall be first exhausted prior to provision of coverage under any policy of insurance maintained by CCA-CFA or the volunteer driver.
  
3. I intend by the Transportation Waiver and Release to release, in advance, and to waive my rights and to indemnify, defend, and hold harmless the Released Parties with respect to any and all claims and any cost, expense, liability or damage, including reasonable attorneys’ fees and expenses related to the investigation or defense of any claims, resulting from the activities necessary to transport CCA-CFA students.
  
4. Should any portion of this Transportation Waiver and Release be judicially determined invalid, voidable, or unenforceable for any reason, such portion of this Transportation Waiver and Release shall be severable from the remaining portions herein and the invalidity, voidability, or unenforceability thereof shall not affect the validity, effect, enforceability, or interpretation of the remaining provisions of the Transportation Waiver and Release.
  
5. I have carefully read this Transportation Waiver and Release and fully understand its contents. As parents or legal guardians, we have completely reviewed this Transportation Waiver and Release, understand and consent to its terms, and authorize transportation accordingly. I am aware that this is a RELEASE OF LIABILITY and a contract between me and the person and entities mentioned above and I sign of my own free will.
